**A RESOLUTION AUTHORIZING THE EXECUTION OF
THE COOK COUNTY COMMUNITY DEVELOPMENT
BLOCK GRANT PROGRAM (CDBG) 2018 PROGRAM
YEAR APPLICATION FOR THE VILLAGE OF BURNHAM,
COOK COUNTY, ILLINOIS**

WHEREAS, the Village of Burnham, Cook County, Illinois is a home rule unit pursuant to Article VII of the Constitution of the State of Illinois of 1970 by virtue of a referendum held on March 11, 1980; and

WHEREAS, the Corporate Authorities of the Village of Burnham deem it to be in the best public interest to make application for Cook County Community Development Block Grant Program funds for 2018 Program Year; and

WHEREAS, the Corporate Authorities of the Village of Burnham deem it to be in the best public interest to request Cook County Community Development Block Grant funds for 2018 Program Year in the total amount of Eighty-Five Thousand and No/100 Dollars (\$85,000.00) for one (1) capital improvement project.

NOW, THEREFORE, BE IT RESOLVED by the President (Mayor) and Board of Trustees of the Village of Burnham, Cook County, Illinois as follows:

Section 1. That a Request is hereby made to the County of Cook, Illinois for Community Development Block Grant ("CDBG") funds for Program Year 2018 in the amount of Eighty-Five Thousand and No/100 Dollars (\$85,000.00) for the following project:

as identified in the Village of Burnham's CDBG 2018 Program Year application.

Section 2. That the President (Mayor) and Clerk of the Village of Burnham, Cook County, Illinois are hereby authorized to sign the application and various forms contained therein, make all required submissions and do all things necessary to complete the application for funds requested in Section 1. of this Resolution, a copy of which application is on file with the Village Clerk.

Section 3. That the President (Mayor) of the Village of Burnham, Cook County, Illinois is hereby authorized to certify that matching funds which have been identified as supporting its project as set out within its application will be made available upon the approval of the project by the County of Cook, Illinois or the prorated share thereof.

Section 4. This Resolution shall be in full force and effect from and after its passage, and approval as provided by law.
